Mariusz Biały specializes in capital markets law as well as commercial and financial law. Associated with Polish capital market since 2003. Prior to joining our Legal Team he gained experience at the largest investment fund management companies operating on the Polish market.

Mariusz provides day-to-day services for entities supervised by the Polish Financial Supervision Authority including investment funds, pension funds and management companies, entities participating in the distribution of participation units and specializing in managing debt portfolios of securitization funds. He also participates in licensing proceedings (including those related to obtaining a permit from the Polish Financial Supervision Authority to undertake activities by the supervised entity) and supervisory proceedings related to their activities. He cooperates with entities servicing the activities of the aforementioned institutions in regard to the preparation of offers of public investment certificates of closed-end investment funds (custodian bank, investment firms, transfer agents, KDPW, WSE). An important area of his specialization is the issues of pension products (including: IKE, IKZE, PPE and PPK) as well as issued related to MiFID II, AML and the protection of personal data. He participated in projects of an advisory nature as well as related to the creation of PPE or registration of changes to these programs, including PPE conducted by employers belonging to Polish and foreign capital groups.

Mariusz Biały graduated from the Faculty of Law, Administration and Economics at the University of Wrocław, defending his master's thesis on trade issues in the EU's single internal market. He completed postgraduate studies at the Warsaw School of Economics conducted by the Department of Project Management with the defense of his thesis entitled „Project management in the process of creating investment funds – selected issues” (work evaluation: excellent). As a doctoral student at the Faculty of Law and Administration of the University of Warsaw he conducted research on Polish and foreign legal regulations concerning collective investment institutions.

He represented our Legal Office in the course of legislative work coordinated by the Ministry of Finance on the activities of financial institutions and the products and services offered by these entities (related, inter alia, to the implementation of MiFID II), including the legislative process regarding the draft act on employee capital plans (PPK). He is also the author of publications on the issues of MiFID II and employee capital plans, and a speaker at training courses addressed to financial institutions on AML, confidential information protection and PPK.
